AMENDED CONSENT ORDER

The West Virginia Board of Osteopathic Medicine ("Board") and Allison Collier, D.O. ("Dr. Collier"), agree to entry of the following Consent Order pursuant to W. Va. Code § 30-14-1 *et seq.*, W. Va. Code § 30-1-1 *et seq.*, and the rules of the Board.

FINDINGS OF FACT

The Board and Dr. Collier stipulate to the truthfulness and accuracy of the following facts:

1. Dr. Collier is a licensee of the Board, possessing Board-issued license number 4117 to practice osteopathic medicine and surgery in the state of West Virginia.
2. Dr. Collier previously self-enrolled in the West Virginia Medical Professionals Health Program ("WVMPHP").
3. On March 15, 2024, the WVMPHP informed the Board in writing that Dr. Collier was non-compliant with her agreement with the WVMPHP, which led the Board to initiate Complaint No. 2024-12 on May 7, 2024.
4. Dr. Collier subsequently moved to another state and entered into a monitoring agreement with that state's physician health program ("Primary Monitor").
5. The Board finds that Dr. Collier's continued practice of osteopathic medicine requires a program of evaluation and/or treatment under terms that may be revoked or modified at any time that there is probable cause to believe that such program should be modified.

6. The Board and Dr. Collier voluntarily enter into this Consent Order to resolve Complaint No. 2024-12.

### **CONCLUSIONS OF LAW**

1. The West Virginia Board of Osteopathic Medicine is a board of examination and registration created for the purpose of protecting the public through regulation of the practice of osteopathic medicine and surgery in the state of West Virginia. W. Va. Code § 30-14-1 *et seq.*

2. The Board, in executing its duties, is authorized to enter consent orders, and the Board finds that entry of a consent order is appropriate in this case. W. Va. Code § 30-1-8(g) and W. Va. Code R. § 24-1-18.

### **ACKNOWLEDGMENT OF RIGHTS**

I, Allison Collier, D.O., having read this document and by signing my name to it, understand and acknowledge the following:

1. This is a legally binding document that affects my rights and privileges.
2. I have the right to consult a lawyer concerning the terms of this agreement and the legal rights and remedies that may otherwise be available to me, and I have exercised that right in this case.
3. I understand that, without my consent, no permanent legal action may be taken against me except after a hearing.
4. I understand that, instead of accepting this agreement, I may demand that the Board prove the charges against me by presenting evidence in a hearing conducted under law. If I chose to have a hearing, I would not have the burden of proof. I could, however, present evidence on my own behalf and I would have the right to cross-examine any witnesses who might

testify against me. I also understand that I have the right to subpoena witnesses and records in order to compel their production at the hearing.

5. I knowingly and voluntarily waive all such rights and agree to entry of this Consent Order.

6. I acknowledge that this agreement is a legally binding Order. I also acknowledge that, if I violate any terms and conditions of this Order, the Board may take further action as permitted by law.

7. I understand that this is a public document and that the Board is legally obligated to allow any person to review this Consent Order. I also understand that this action and Order may be reported to other boards, to other jurisdictions, to the National Practitioner Data Bank, to the Federation of State Medical Boards, and as otherwise required by law.

8. I understand that, as a result of this Consent Order, other licensing boards and authorities may take adverse action against my licenses as allowed by the laws and regulations governing those boards and authorities.

#### **TERMS OF ORDER**

**WHEREFORE**, based on the foregoing Findings of Fact and Conclusions of Law, and with the consent of Allison Collier, D.O., the West Virginia Board of Osteopathic Medicine **ORDERS** as follows:

1. Dr. Collier shall comply with all treatment recommendations and requirements established by the monitoring agreement with the Primary Monitor and any reciprocal agreements, and said agreements shall be submitted to the Board;



2. The Primary Monitor<sup>1</sup> will provide written documentation to the Board on a quarterly basis verifying Dr. Collier's compliance with all aspects of the agreements during the period of treatment and monitoring and will deliver a final report at least 14 days prior to the end of this period;

3. Dr. Collier will give her written authorization that all records relating to her care, treatment, and monitoring, including medical records, may be disclosed to the Board for its review, consideration, and use in any subsequent proceedings before the Board;

4. Dr. Collier is financially responsible for payment of all expenses for treatment, counseling, monitoring, and the other terms and conditions of this Consent Order;

5. Dr. Collier will conduct herself in a professional manner in all aspects of her work and practice and will remain free of any charges of unprofessional conduct or disciplinary action before this Board, any corresponding board in any other jurisdiction, any other state or federal agency, or before any hospital, peer review committee, or medical corporation or partnership;

6. Dr. Collier will be truthful and forthright in all communications with the Board;

7. Dr. Collier shall not violate or be charged with any criminal laws of the state of West Virginia, the United States, or any other state, possession, or territory of the United States;

8. If Dr. Collier fails to comply with, or complete any of the terms stated herein, the Board may rescind or modify this Consent Order and take any other action, including revocation of Dr. Collier's license, that is authorized by law;

9. The preceding terms and conditions apply, and shall remain in effect, unless modified by order of the Board; and

<sup>1</sup> The original Consent Order required the WVMPHP to report to the Board. This Amended Consent Order simply makes a technical amendment requiring the Primary Monitor to report to the Board.


10. In order to be released from the restrictions of this Consent Order, Dr. Collier must apply to the Board to lift the restrictions and must demonstrate that she has satisfactorily completed and complied with all of the terms of this Consent Order.

11. The effective date of this Consent Order is October 9, 2024.

**ACKNOWLEDGMENT OF LICENSEE:**

I have reviewed the provisions of this Consent Order. I agree to abide by the terms set out herein and to be bound by them.


