# Anti-kick back provisions are in violation of osteopathy physician licensing rules

Legal counsel has reviewed 24 CSR 1.18.1 and 18.1.17 and determined that the language in the **Three Rivers Health Plan**, **Inc.** appears to be in direct violation. As physicians, you must carefully review all of your contracts with insurers and other parties to avoid signing a contract that violates our rules. Penalty for this would be suspension/revocation/restriction placed on you license. If you are uncertain if a plan you are signing is in violation with our law you may contact the board office at 304-723-4638 and we will investigate the matter for you.

Any private activities that could be related back to your professional practice needs reviewed in relation to the Board's rules and regulations. Please remember that you are a physician 24 hours per day. An individual is more apt to accept what you say as a physician. If choose to do this, it must be in the best of interests for the patient not for your own financial gain. You may refer to 24 CSR 18.1.22

## Continuing Medical Education for License Renewals (Hours must be from 7/1/98 thru 6/30/00)

You are required to have a total of 32 hours AOA approved. Of those 32 hours at least 50% or 16 hours must be category 1 A or B. The other 16 hours may come from any other source. AOA generally approves all CME hours, but not necessarily all as category 1. *Standardized Life Support Courses* count as Category 1A with the following hours as credits.

Preceptoring osteopathic medical students count as category 1. We must receive a letter from the school stating the number of hours you taught or it must be recorded on your AOA individual activity report.

**Residents** - must have a letter from their Director of Medical Education, stating residency dates.

Military - must have current copy of their service card stating active status dates.

Videos - are category 1B provided they were ordered through Oklahoma State University, College of Osteopathic Medicine at (800) 274-1972.

In any event if you are a member of the AOA you probably need only to attach a copy of your most recent AOA individual activity report.

#### PLLC ANNUAL RENEWALS

Renewal forms are not sent, you are required by law to submit a copy of your annual report (that was filed with the Secretary of State office on 4/15/2000) and a check in the amount of \$100.00. If you PLLC has dissolved, we will need a copy of your dissolution paper from the Secretary of States Office.
